Initiation Fee: The undersigned agrees to pay the membership initiation fee, in the amount determined annually by the Board of Directors, and understands that the entire initiation fee is due upon acceptance of membership, is non-refundable and non-transferable and that as a courtesy it is payable in installments of one-half upon joining and the remainder by March 1 of the following year.

Annual Dues: The applicant agrees to pay the annual dues, determined annually by the Board of Directors, by March 1 of each year, and understands that membership covers a family, including unmarried and dependent children living in the household. At such time as there is an opening in Skyline Acres and upon approval of this application by the Membership Committee of the Board of Directors and the receipt of the applicable fee and dues, membership will be effective.
